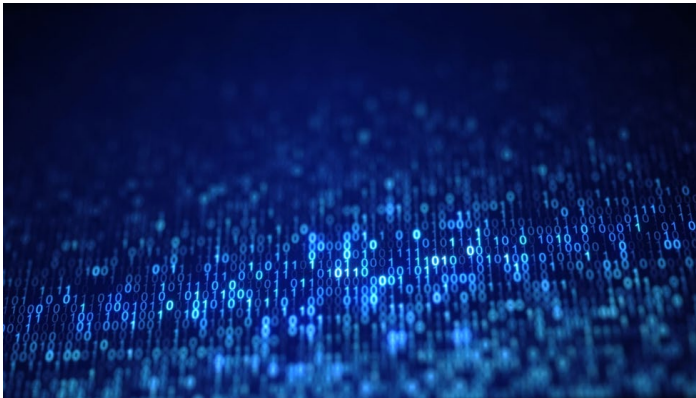

What's New? Recent Updates to TRACS

Federal Award Reporting Dates: Added functionality for Federal Approvers to generate, edit, and manage Federal Award Reporting Due Dates for Performance Reporting, including budget and reporting cycles, waivers, and extensions (more information [here](#)).

Clear Questionnaire Button: New functionality added enabling TRACS users to clear the performance questionnaire responses.

2022 Wildlife Management Areas: Wildlife Management Areas (WMAs) are now available for selection. In the Geographic Location section, users have the option to “Select one or more detailed locations (optional)” and select from a list of U.S. WMAs. If a WMA is not listed, please contact the TRACS Help Desk.

TRACS Performance Matrix: The TRACS Performance Matrix has been updated to version 21 (updated on 4/8/2024). The current Matrix and related tools are available on the [TRACS Resources & Job Aids page](#).

Real Property Records: Users who are ready to submit or make corrections to legacy Real Property (Lands) records for ingestion into TRACS should contact the TRACS Help Desk to begin the process.

User Administration and Management: User Administrators should NOT click “Deny” if a user request is valid but incorrect roles/permissions were selected. Instead, approve the user, then select the appropriate roles. User Administrators can edit user permissions and roles by selecting “Manage Groups,” then select the user and click the “Edit User Permissions” link. Facility Records: If your report includes an objective for ‘Facilities Construction, Renovation, or Acquisition,’ a facility record must be created and approved in the Inventory Module. In the case of multi-year grants, the facility record(s) will need to be linked to the report for the period of performance when the facility was constructed, renovated, or acquired. For interim years when the facility has not yet been completed, the user should select “No” for quantifiable result to report and enter an explanation (i.e., Construction is underway).
